**Date and Location:** Saturday, June 15<sup>th</sup> on the Attales Cross Country Course behind the Absecon School Complex.

\*The event will be held rain or shine. **There are no refunds.**

**Time:** 8:00-8:45 AM- check in at the back of the Attales School in the parking lot.

9:00 AM -Run/walk begins \*There will be a final color throw at the finale with all participants.\*

**Registration:** Please fill out the registration form below and return along with the fee to school by May 31st.

**NO REGISTRATIONS WILL BE ACCEPTED THE DAY OF THE EVENT.** All children MUST be accompanied by an adult at the event, but may participate on their own.

**Fee:** \$10 per person. A family of 4 or more \$40 maximum. Children under 4 are free. Total balance must be paid in full, and registration form must be completed by May 31<sup>ST</sup>. Please make checks payable to the Absecon Education Foundation. The registration fee includes the run/walk and individual color pouch for finale.

**Course:** The course will be 1.5 miles around the school with color stations throughout where participants will be doused with color powder. This is NOT a timed run/walk. Everyone wins!

**HINTS:** Wear a white t-shirt (Hometown Variety Store has them), wear sunglasses, and bring a towel for the car ride home!

**COLOR FUN RUN/WALK 2019 WAIVER AND RELEASE OF LIABILITY**

**PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING.**

I understand and agree that my/my child's participation in the Color Fun Run/Walk 2019 is voluntary. Furthermore, I understand that the Color Fun Run/Walk 2019 is a potentially hazardous athletic activity during which colored powder will be thrown at or near me while I/my child run(s)/walk(s) through the designated 1.5 mile course. I further understand that the colored powder has not been tested for chemicals or disease and may pose a health risk if ingested, inhaled and/or otherwise exposed to me/my child. I understand and agree that like any extreme athletic event, there is a potential for death, serious injury, property loss and other risks that may be associated with my/my child's participation in the Color Fun Run/Walk 2019, including but not limited to risks that may be caused by and/or result in: inhalation/ingestion/exposure to colored powder; slips; falls; injuries of all types; contact with other participants; my/my child's negligent acts; negligent acts of others; weather related risks such as high heat, cold, rain, snow and ice; wild animals and insects that may be on the premises; any and all defects and conditions that may be on the premises; terrain; facilities; course conditions; condition of participants; equipment; vehicular traffic; lack of hydration; the actions of other people, including Color Fun Run/Walk 2019 participants, volunteers, spectators, coaches, event officials, event sponsors, facility owners/managers, event monitors and/or the event organizers (hereinafter collectively referred to as the "Associated Risks"). The Associated Risks are not only inherent to athletes, but are also present for volunteers.

I certify that I/my child am/is physically fit, have/has sufficient training and skills for participation in the event, and have not been advised otherwise by a qualified medical professional. I agree that I/my child will only participate in the Color Fun Run/Walk 2019 based upon my determination that I/he/she am/is medically and physically able to do so. I understand and agree that the foregoing determination of medical and physical ability is my sole responsibility.

I hereby assume all of the risks, including the Associated Risks, of my/my child's participating and/or volunteering in this event.

I understand, acknowledge and accept that there are risks of physical injury and property damage to participants, volunteers and spectators related to the Color Fun Run/Walk 2019 and I voluntarily and knowingly agree to assume the Associated Risks and the risk of any and all injuries, damages and/or loss, regardless of severity and fault that I/my child may sustain as a result of my/his/her involvement in the Color Fun Run/Walk 2019.

In consideration of my/my child's participation in the Color Fun Run/Walk 2019, I hereby fully release and forever waive, relinquish and discharge for myself, my child, my/my child's executors, administrators, heirs, next of kin, successors and assigns, any and all claims that my child and I may have and/or may accrue as a result of my/my child's participation in the Color Fun Run/Walk 2019, including but not limited to claims against the following entities: the Absecon Education Foundation and the Absecon Board of Education, their directors, officers, employees, staff, representatives, agents, event organizers, event sponsors, event directors and the event volunteers (hereinafter collectively referred to as "Releasees"). The foregoing release, waiver, relinquishment and discharge applies to any and all claims, including but not limited to: any and all claims for injuries, including death and/or incapacity, illnesses, damages, expenses or losses that I/my child may suffer arising out of, connected with, or in any way associated with the Color Fun Run/Walk 2019.

I understand that I/my child may be photographed and recorded at Color Fun Run/Walk 2019. I agree to allow my/my child's photograph, video, film, image and likeness to be used for any purpose by the Absecon Education Foundation and the event sponsors, their producers and/or assigns without any remuneration.

I hereby consent to receive/for my child to receive medical treatment which may be deemed necessary in the event of injury, accident or illness during the event.

I understand and agree that the provisions herein shall be construed as broadly as possible to provide a full and complete release and waiver to the Releasees under all applicable laws. I hereby certify that I have carefully read, accepted and agreed to the terms that are contained within this document.

The undersigned parent and natural guardian or legal guardian does hereby represent that he/she is, in fact, acting in such capacity and agrees to all of the terms contained herein, including the agreement to save and hold harmless and indemnify Releasees from all liabilities, losses, costs, claims and damages, which may be imposed upon Releasees due to any defect in or lack of such capacity to so act and release Releasees on behalf of the minor and his/her parents or legal guardians.
